Acting in our capacity as an asbestos management consultant retained by Green Township School District, Partner Engineering and Science, Inc. (Partner) has recently completed the periodic surveillance required for the subject facility by the "Asbestos-Containing Materials in Schools Rule" (40 CFR 763, Subpart E). The inspection was performed pursuant to 40 CFR 763.92(b) by an accredited AHERA Building Inspector.

It should be understood that the scope of this inspection was limited to the re-inspection of Asbestos-Containing Building Materials (ACBMs) previously identified at the subject facility in its Asbestos Management Plan. Many building materials (i.e. floor tiles, mastics, roofing materials, etc.) are still manufactured with asbestos. As such, it is possible that asbestos products have been installed since the original inspection was completed. If any suspect asbestos containing building materials (including 12"x12" floor tiles) are present that have not been sampled, these materials should be sampled.

Observations made during the surveillance indicated there is no damage to the ACBM identified at the subject facility. Continued operations and maintenance activities are indicated as appropriate response action. See Table 1 for specific locations.
