II. DISCUSSION OF TRANSPORTATION FOR THE 22/23 SCHOOL YEAR

The Board discussed the non-renewal of the transportation contract with First Student.

The Superintendent, Dr. Cenatiempo and Board Members discussed the following:

- -Length of day with current busing, potential changing of times for next year
- -Is it possible to cut the number of buses needed from 10 to 7
- -If less buses, the length of the bus route
- -Can we have one less bus for the high school routes
- -Is there an economical way to buy our own buses, not easy to get bus drivers, repairs, need for a transportation coordinator
- -Discussion of subscription busing, safety, complications of the school parking lot, hazardous routes
- -Concerns about a longer day for students
- -Finding out how many students live within a 2 mile radius of the school
- -Potential of a late bus, additional cost
- -Impacts to the budget-Cost will not be known until the end of May or even June
- -What information is needed for the Sussex County Co-Op to go out to bid for transportation
